CHAPTER 5, PARA 5005D(2)

B. DEFENSE TRANSPORTATION REGULATION (DOD 4500.9-R)

1. REF A STATED THAT STORAGE BASED ON 15 AND 30-DAY INCREMENTS WILL  
BE CERTIFIED IF THE SHIPMENT IS STORED BEYOND THE INITIAL STORAGE  
PERIOD. REF B REMOVED THE EXCEPTION AND REQUIRED THAT ALL DD FORMS  
619/619-1 BE CERTIFIED FOR STORAGE-IN-TRANSIT (SIT), REGARDLESS OF
