

PASS TO ALL PERSONAL PROPERTY SHIPPING OFFICES WORLDWIDE

SUBJECT: TRANSPORTATION SERVICE PROVIDERS (TSPS) REVOCATION ACTIONS FOR ALL-WAYS INTERNATIONAL FORWARDING, INCORPORATED (AWIF), BISSON MOVING STORAGE (BISS), FEDERAL VAN & STORAGE, INCORPORATED (FEDL), AND RYAN'S WORLD, INCORPORATED (RYNW)

1. AS OF 16 JULY 2012 AWIF, BISS, FEDL, AND RYNW ARE REVOKED FROM PARTICIPATING IN THE DOD PERSONAL PROPERTY PROGRAM FOR ALL CODES OF SERVICE.
2. ALL PPSOS SHOULD FOLLOW PROCEDURES OUTLINED IN THIS MESSAGE.
3. NO NEW TONNAGE SHALL BE OFFERED TO SUBJECT TSPS INTO OR OUT OF ALL AREAS WORLDWIDE.
4. WITHIN THREE (3) WORKING DAYS FROM THE DATE THIS MESSAGE IS RECEIVED, PPSOS SHALL PROVIDE THE HQ SDDC OPERATIONS TEAM A LIST OF ANY SHIPMENTS THAT HAVE NOT ARRIVED AT DESTINATION BY THE REQUIRED DELIVERY DATE (RDD).
5. AWIF, BISS, FEDL, AND RYNW ARE RESPONSIBLE TO CONTINUE THE MOVEMENT OF ANY SHIPMENTS THAT HAVE BEEN AWARDED TO THEM FROM ORIGIN THROUGH TO FINAL DELIVERY, TO INCLUDE DELIVERY OUT OF SIT.
6. PPSOS NEED TO NOTE IN SHIPMENT MANAGEMENT AND INVOICING TSPS' RESPONSIBILITY FOR DELIVERY OUT AND CLAIMS SETTLEMENT.
7. IAW PARAGRAPH 4 ABOVE, PPSOs SHOULD SEND THE LIST OF SHIPMENTS THAT HAVE NOT ARRIVED BY THE RDD VIA E-MAIL, MAIL, OR FAX AS FOLLOWS:
