

SUBJECT: TRANSPORTATION SERVICE PROVIDER (TSP) REVOCATION ACTION FOR BEKINS VAN LINES, LLC (BVLC).

1. AS OF 21 OCT 2011, BVLC IS REVOKED FROM PARTICIPATING IN THE DOD PERSONAL PROPERTY PROGRAM.
2. ALL ITOS SHOULD FOLLOW PROCEDURES OUTLINED IN THE DEFENSE TRANSPORTATION REGULATION (DTR) PART IV, CH 410, PAR. F.2, PAGE IV-410-10.
3. NO NEW SHIPMENTS SHALL BE OFFERED TO THE TSPS LISTED ABOVE.
4. ITOS SHOULD PROVIDE HQ SDDC WITHIN THREE (3) WORKING DAYS FROM THE DATE THIS MESSAGE IS RECEIVED A LIST OF ANY SHIPMENTS THAT HAVE NOT ARRIVED AT DESTINATION BY THE RDD.
5. SHIPMENTS ALREADY BOOKED WITH BVLC, AND STILL AT ORIGIN OR SHIPMENTS THAT ARE BOOKED AND HAVE NOT BEEN PICKED UP, MUST BE PULLED BACK AND RETENDERED TO OTHER TSPS WITH THE SAME AGENT IF POSSIBLE.
6. SHIPMENTS PLACED IN STORAGE-IN-TRANSIT (SIT) OR ALREADY IN SIT, SHALL BE TERMINATED EFFECTIVE THE DATE THEY ARE PLACED IN STORAGE.
7. BVLC IS RESPONSIBLE FOR COMPLETING THE MOVEMENT OF SHIPMENTS IN THE PIPELINE (I.E., SHIPMENTS THAT HAVE MOVED BEYOND THE ORIGIN AGENT'S WAREHOUSE).
8. IAW PARAGRAPH 2 ABOVE, ITOS MUST KEEP COPIES OF THE ORIGINAL GBLS, RETENDERED GBLS, CORRECTIONS NOTICES, PURCHASE ORDERS OR FREIGHT WARRANTS, AND ANY BILLS PAID FOR SHIPMENTS THAT WERE RETENDERED. BOTH ORIGIN AND DESTINATION ITOS MUST PROVIDE COPIES OF THE ORIGINAL AND RETENDERED GBL TO HQ SDDC ONCE SHIPMENTS HAVE ARRIVED AT DESTINATION. THIS CAN BE DONE BY MAIL, FAX OR EMAIL, AS FOLLOWS:

10. REQUEST DESTINATION ITOS ADVISE MEMBERS THAT THEIR PERSONAL PROPERTY MAY BE DELAYED AS A RESULT OF THIS ACTION.
11. SHIPMENTS THAT BECOME FRUSTRATED MUST BE REPORTED TO HQ SDDC FOR ADDITIONAL GUIDANCE AND INSTRUCTIONS.
12. THE SCOPE OF THIS DECISION IS LIMITED TO YOUR PARTICIPATION IN THE SDDC

PERSONAL PROPERTY SHIPMENT PROGRAM AND WILL NOT BE BINDING OR OTHERWISE AFFECT YOUR STATUS TO PARTICIPATE IN OTHER SDDC PROGRAMS IN WHICH YOUR COMPANY OR AFFILIATES MAY BE INVOLVED (EX., NON-TEMPORARY STORAGE PROGRAM).
