Subject: Military Freight Traffic Unified Rules Publication (MFTURP-1) Available for Review and Comment

Purpose: Inform Department of Defense (DoD) Stakeholders and Transportation Service Providers (TSPs) that the MFTURP-1 is now available for review and comment.

Be Advised: The SDDC G3 Outreach and Engagement Team conducts a full-scale review and update of the MFTURP-1 every three years. The next update will begin on **29 January 2024 and will close 8 March 24.**

This review allows DoD Stakeholders and TSPs to provide comments and propose updates to the MFTURP-1 in its entirety. DoD Stakeholders and TSPs have six weeks to provide comments.

The MFTURP-1 and associated documents are located on the MFTURP Adjudication Program page of the SDDC website at: <https://www.sddc.army.mil/>. Stakeholders should click on the "Motor", "Rail", "Air" or "Ocean/Barge" tab, then select "MFTURP-1 Adjudication Program" under the "System and Program Access" title to view the documents and Comment Matrix.

USTRANSCOM has proposed significant changes to Section A (Transportation Provider General Rules) and Section F (Air Transportation Service Provider Rules); mandated, administrative and major revisions are included.

Air Carriers should complete a thorough review of the changes to Sections A and F.

Updated versions of Sections A and F are attached to this advisory. They have also been posted to the MFTURP-1 Adjudication page. Stakeholders should review the draft versions of these sections. **Any changes, updates or revisions that need to be made to either section must be based on the re-written versions attached here and provided on the SDDC website.**

Stakeholders should use the version of the MFTURP-1 attached to this advisory or found on the MFTURP-1 Adjudication Program website. Do not use past versions of the MFTURP-1 as line numbers may have changed. Please verify that the line numbers associated with comments and proposed changes are correct prior to submission.

DoD Stakeholders and TSPs may review the documents and submit comments to the MFTURP-1 Team at usarmy.scott.sddc.mbx.g3-domestic-mfturp@army.mil.

Comments must be submitted using the Comment Matrix document posted on the website.

Please annotate and provide exact verbiage proposal(s) to include paragraph number, line number, page number, and POC information. Failure to provide this information may impact the final publication date. **Provide comments via the attached Comment Matrix. Comments submitted in any other format will not be accepted.**

Comment period runs from **29 January 24 – 8 March 24**. All comments and input must be received by **8 March 2024** via email at usarmy.scott.sddc.mbx.g3-domestic-mfturp@army.mil.

Expected publication date for the updated MFTURP-1 is August 2024 however, final publication date may shift to ensure sufficient time to review and adjudicate comments and concerns. Updates on the revision effort will be provided as needed via Customer Advisory.
