Subject: Proposed Update to the Military Freight Traffic Unified Rules Publication (MFTURP-1); Addition of Deficit Weight Rating Language

Purpose: To solicit feedback from Department of Defense (DoD) stakeholders and Transportation Service Providers (TSPs) on proposed addition to MFTURP-1 Section A, Part IV.C., *Tender Rate Sections D,E, G Through I*, Paragraph 1.e.

Rationale: Deficit Weight Rating is a costing method performed by the Global Freight Management (GFM) system, but was not documented in previous versions of the MFTURP-1. The proposed addition will formally document this costing procedure for full transparency. DoD stakeholders and TSPs have the opportunity to review the proposed addition of Deficit Weight Rating language.

Be Advised: SDDC G3, in coordination with SDDC G6, drafted language outlining the procedures for Deficit Weight Rating. This language will be added to MFTURP-1 Section A, Part IV.C., *Tender Rate Sections D,E, G Through I*, Paragraph 1. For reference, the proposed paragraph e. will be located on page 37 of the current MFTURP-1 (effective date 23 March 22).

DoD stakeholders and TSPs should review the Deficit Weight Rating documents and submit comments to the MFTURP-1 Team at usarmy.scott.sddc.mbx.g3-domestic-mfturp@army.mil. Comments will not be taken via the SDDC Docketing System.

A Summary of Changes document is not required. This proposed change is an addition to the publication and does not include changes to existing language.

NOTE: Comments must be submitted using the **Comment Matrix** document posted to the website.

The comment period runs from 27 April to 11 May 2022. Only comments pertaining to the proposed addition, Deficit Weight Rating, in Section A, Paragraph 2.e. will be accepted. Responses should include concurrence/non-concurrence. Provide the exact verbiage and line number on the matrix if recommending a change to the Deficit Weight Rating language.

The proposed revision is located on the Domestic Movement Support page of the SDDC website at <https://www.sddc.army.mil/dms/Pages/default.aspx>. Stakeholders should click on the "Regs & Docs" tab to view the proposed language and Comment Matrix.

Comments will be adjudicated and used to create an updated version of the MFTURP-1. Stakeholders will be notified by Customer Advisory when an updated

MFTURP-1 containing this language is published.
