 DoD approved carrier, registered in the Freight Carrier Registration Program (FCRP) to participate in this segment of

- 2. Negotiated 500000 series tender solicitations are a rate-based email notification process and is provided solely as a service to DoD-approved carriers who have elected to participate in this segment of business supporting the SDDC freight transportation process. All negotiated bid responses MUST be emailed to usarmy.scott.sddc.mbx.negotiations-team@army.mil. SDDC is not responsible for undeliverable email notifications due to incorrect email addresses, communication problems, or other internet or local area network issues. This process is intended solely to notify carriers of negotiated solicitations and receive carrier proposed tariff/tender rates to support said business. There are no direct or implied warranties or guarantees of any kind. Carriers that have concerns about their bids being received in a timely manner or have experienced difficulties in the past with timely bid submissions not received by SDDC prior to solicitation closeout, please consider the following voluntary options:
 - a. Send bid response with "Request a Delivery Receipt" or "Request a Read Receipt" option.
 - b. "Cc" the Traffic Management Specialist (TMS), who issued the solicitation, in your bid response.
- 3. It is imperative for all TSPs to read the solicitation letter and know when the closing (date/time) of each respective solicitation is, to allow ample time for Special Requirements Branch to receive your response as we have experienced email latency. **By signing below, the carrier agrees to the provisions above. Any unauthorized use of this information is strictly forbidden.

GENERAL INSTRUCTIONS

1. Company/Contact Information:

- a. Only one (1) TSP Worksheet and one (1) point of contact can be submitted per SCAC. Recommend using org/group email.
- b. Item selected under "MODE" must match FCRP registration.
- c. Item selected under "DOT AUTHORITIES" must also match SCAC registration in FCRP.

2. Email Groups:

- a. Select the group that best represents the type of equipment you have to offer, even if you only have one (1) type of equipment in that group.
- b. If you are submitting a TSP Worksheet for a "motor" SCAC, **do not** select the barge or rail groups, submit separate TSP Worksheet as they should have their own SCACs registered separately in FCRP.

3. Motor Transportation Protective Services (TPS):

- a. MUST be approved in FCRP to select any TPS services.
- b. MFTURP-1 prohibits brokers, freight forwarders and logistics companies from handling or accepting any shipments requiring TPS services.

4. Signature and Tally Record accessorial (675)

- a. MUST be registered in FCRP as an "Asset Based" (Common FAK) carrier to select this service.
- b. MFTURP-1 prohibits brokers, freight forwarders and logistics companies from handling or accepting any shipments moving with 675 service.
