INTEGRATING DEFENSE NEEDS INTO THE PUBLIC HIGHWAY SYSTEM

IDENTIFY AND INTEGRATE DEFENSE HIGHWAY NEEDS INTO PUBLIC HIGHWAY PROGRAMS

- Develop and update the Strategic Highway Corridor Network (STRAHNET) and STRAHNET Connectors at:
<http://www2.tea.army.mil/DODProg/HND/Systems.htm>
- Ensure STRAHNET & STRAHNET Connectors continued incorporation into the National Highway System
- Serve as DOD's liaison to the Federal Highway Administration (FHWA) & State Departments of Transportation
- Coordinate with FHWA to ensure existence of standard vertical clearance routes for movement of oversize/overweight military vehicles
- Serve as focal point for the Federal Lands Access Program & the Emergency Relief for Federally Owned Roads (ERFO) Program

ENHANCE DOD'S USE OF PUBLIC HIGHWAYS

- Serve as proponent for Appendix F, Permits for Military Movements on United States Public Highways and Army Convoy Operations and Procedures, Part III, Mobility Section, Defense Transportation Regulation (DOD 4500.9-R)
- Coordinate with FHWA and States to enhance defense movement capabilities on public highways through agreements, regulation, or legislation
- Publish Directory of Highway Permit and Movement Control Officials at:

- Coordinate Military emergency preparedness issues with FHWA, States, and other emergency agencies
- Conduct engineering analyses to enhance the movement capabilities of unique military vehicles

 - FHWA
 - AASHTO
 - Military services/installations
